Pursuant to ORS 223.680(6) and 223.685(5), in order to qualify for **Property Fit** Financing, property owners are required to:

- (a) Provide a written notice to all mortgagees of the qualifying real property, indicating the property owner intends to participate in the PROPERTYFIT Program and obtain PROPERTYFIT Financing by entering into a loan or financing agreement and other transaction documents, and authorizing the recording of a Benefit Assessment Lien against the qualifying real property.
- (b) Obtain written consent, in a form acceptable to the Program Administrator, from all mortgagees stating that the property owner's participation in the PROPERTYFIT Program, including entering into the loan or financing agreement and the recording of a Benefit Assessment Lien, does not constitute an event of default or give rise to any remedies under the terms of its mortgage loan agreements. The form of Mortgage Holder Consent required by the Program Administrator is attached hereto.
